MSO Components

IOWA

The 2018 ISO Annual Meeting was held at the Graduate Hotel in Iowa City on September 16-17, 2018. Sunday's session featured lectures on a variety of interesting topics from the University of Iowa faculty. Topics included early treatment, airway considerations, as well as other clinical pearls. Monday's sessions featured Dr. **Peter Ngan** who discussed *Early Timely Orthodontic Treatment: Is it Worth the Burden?*

On Friday, September 28, 2018, the Iowa Dental Board voted on amendments to Iowa Administrative Code 520-Chapter 28 "Advertising," and "Designation of Specialty." The Board voted unanimously to adopt the amendments to the specialty advertising regulations, which was the desired result, especially since previously the Iowa Dental Board was considering removing its specialty advertising regulations altogether.

The Board's vote marked the final chapter of the AAO helping Iowa with this specialty advertising issue. Thanks to the AAO's Component Legal Support Fund, the AAO has worked with the Iowa Dental Board since 2017 to revise, rather than remove, Iowa's specialty advertising laws. AAO Attorney **Sean Murphy** attended the September meeting with Drs. **Marc Welge** and **Tom Stark**. Both Mr. Murphy and Dr. Stark provided comments to the Board in favor of Iowa retaining its specialty advertising laws. In the end, all of the AAO's and Iowa orthodontists' efforts paid off with the Board voting in favor to keep Iowa's specialty advertising laws.

Some of the recent highlights occurring in the Manitoba Orthodontic Society (MOS) are as following:

My name is Dr. **Keri Barrow**, and I have accepted the South Dakota MSO director's position previously held by Dr. **John Kharouf**. Thanks to John for his service to the MSO. I have been in practice with my father, Dr. **Kevin Horner**, in Sioux Falls for eight years. I look forward to filling this position to the best of my abilities.

SDSO Business:

The South Dakota Society of Orthodontists (SDSO) will hold their 2019 annual meeting in conjunction with the North Dakota Society of Orthodontists CE course scheduled for March 29, 2019 in Fargo. The CE course titled, *Sagittal First: The New Movement in Orthodontics* will feature speaker Dr. **Mike Ragan** from Dallas, Texas. He will present on how using the Carriere Motion 3D appliances can correct the AP dimension, reposition the mandible and reduce over-all treatment time.

2019 South Dakota Dental Association (SDDA) Legislative Issues:

Senate Bill 37 – Association Health Plans

This bill amends existing state law regarding group health insurance in order to allow health insurers to offer a health benefit plan through an association. The bill also allows an association to sponsor a "multiple employer trust" to provide members with a health benefit plan. This bill presents an opportunity for the SDDA to offer a health benefit plan to its members and is supported by the SDDA. It is awaiting the Governor's signature.

Senate Bill 62 – Use certain general funds to increase Medicaid reimbursement rates

This bill requires that 80% of the funds available from savings resulting from "coordinated care agreements" be used to increase reimbursement to Medicaid providers or to fund innovations in Medicaid. This bill failed on the Senate floor.

Senate Bill 137 – Payment of claims for tele-health

This bill requires insurance payment parity for services provided via tele-health. It proposes to ensure that services provided via tele-health are reimbursed as if the services were provided in person. Currently, dental insurance is one of the several types of insurance exempted from the requirements. The SDDA amended the bill to remove dental from the list of insurances exempted in hopes to prohibit attempts by insurance companies to not pay for tele-dentistry services. The bill is awaiting hearing by the House Health and Human Services Committee.

Senate Bill 136 – Utilization of tele-health by health care professionals

This bill provides the parameters under which tele-health may be used. It was supported by the SDDA and is to be heard in the House Health and Human Services Committee.

House Bill 1116 – Prohibit health examinations and screenings in schools without parental consent

This bill would prohibit examinations and screenings without written consent. Routine consent given at the start of the school year would not suffice. The SDDA's requests amendment to this bill to exclude dental exams. Without this amendment the bill would have impacted dental screenings conducted in schools by our volunteers as well as screenings by hygienist's work for the Delta Dental Foundation. The bill received a tied vote in the House of Education Committee and is up for reconsideration.

House Bill 1229 – Require the "optional services" through Medicaid to be authorized through special appropriation

This bill would require that all "optional" Medicaid programs be funded annually through a special appropriation rather than through the Governor's budget. There are many "optional" Medicaid services available. The SDDA amended the bill to limit the bill's effects on "optional" dental Medicaid programs. The bill will be heard in the House.

House Bill 1262 – Reimburse certain family dentists who have complied with the requirements of the tuition reimbursement program.

Through this bill the Department of Health requests funding for the dentists participating in the Tuition Reimbursement program. The SDDA supports this bill, and it has been assigned for review by the Joint Appropriations Committee

Budget – Medicaid Provider Reimbursements

Medicaid funding is included in the bill that funds the general operations of the State Government including the Department of Social Services and Medicaid. The Governor has included at 2.5% increase to the Medicaid provider reimbursements for FY 2020. Moreover, the Governor has included one-time money in the 2019 budget to increase provider reimbursements beginning in April 2019. This funding change will be discussed in the appropriations committee when the Department of Social Services present their budget proposal.

He is finishing his orthodontic cases and will present three of these completed cases during the American Board of Orthodontics - Student Display at the American Association of Orthodontist Annual Session in Los Angeles in May 2019. We are pleased to announce the addition of Dr. **Amy Tasca** to our full-time faculty. Amy completed here DDS at UMKC, practiced for several years in Breckenridge, Colorado and returned to do a combined PhD and Certificate in Orthodontics here at the University of Minnesota. Her PhD was in Oral Biology with a focus on bone biology. Amy will be a great addition to our staff as she will help with guiding and advising research and supervising patient care.

The second-year class just returned from their visit with the orthodontic program at the University of Valencia in Spain, continuing our inter-school relationship with our orthodontic colleagues overseas. They were welcomed into their classrooms and clinics to hear lectures and observe the treatment of patients, leaving our residents with plenty of educative pearls to take home. They particularly appreciated seeing their approach on lingual appliances, TAD placement and utilization, interdisciplinary treatment, and creative treatment mechanics. They were able to have time to enjoy the Spanish culture and their beautiful city.

In the last year, we have made movement to incorporate more digital technology to our resident's educational experience. A major change to our clinic facilities is that we removed the 2D ceph/panorex unit, which had exceeded the unit's lifespan and replaced it with an i-Cat FLX. This location gives a rapid turnaround for diagnostic information. We are now taking intraoral scans on all patients with our six iTero Element scanners. This gives one scanner for every two residents. These changes have made our patient's diagnostic experience more efficient and pleasant.

The last major improvement which deserves special recognition has been the creation of the "Digital Orthodontic Laboratory in 3D". This was possible due to a generous gift from a past graduate, Dr. **Don Nelson.** The vision of this laboratory is "To inspire better orthodontic patient care through the creation, study and application of 3-dimensional data."

Our division wants to be positioned to advance the science and practice of orthodontics through the use of 3D technologies. We want to develop, evaluate and refine new research and treatment collaboration with other experts in the MDRCBB for mathematical modeling, the University medical device center, and the faculty in computer science. The Digital Orthodontic Laboratory contains four 3D intensive graphics computer workstations, a 3dMD facial scanner and two 3D printers. The residents are now beginning to use this technology in their patient care. Thank you again to Dr. Nelson for his generous financial gift to support our orthodontic program at the University of Minnesota.






Adolescents with Class I Occlusion.





Below is the informal 2018 AAOPAC report. A more formal report will be presented at Annual Session. As you can see, it was another successful AAOPAC year, despite an unpredictable election season.

Not only did we raise more AAOPAC money in 2018, we raised \$16,256.42 more than our previous record. Contributions in 2018 totaled over \$353,000, making this the most successful fundraising year in the AAOPAC's 24-year history. Not only did we have a record year in contributions, we also had a record number of AAOPAC contributors. A total of 792 members contributed to AAOPAC, gaining 159 more contributors than in 2017. Constituency Meetings and Match Programs were the two biggest contributors to AAOPAC success in 2018. AMERICAN BOARD OF ORTHODONTICS (ABO)

- <u>Clinical Exam Update</u>: The ABO conducted Clinical Examinations in February and September
 of 2018. A total of 268 examinees were certified or recertified during these examinations. A
 complete listing of newly certified or recertified orthodontists by constituency can be found
 on the <u>ABO website</u>. Registration information for upcoming Clinical Examinations are posted
 on the <u>ABO website</u>.
- Written Examination Update: The ABO Written Examination was administered April 10-13, 2018, at Pearson-Vue Testing Centers throughout the United States and Canada to 414 examinees. The reliability of the examination was 92%, with a 96% pass rate. The next Written Examination will be offered April 10, 2019. Registration for this exam is currently open on the ABO website.

<u>Educational Update</u>:

- The first Scenario-based Oral Clinical Examination will be offered in February 2019, followed by a November 2019 exam. Both sessions are full with wait lists. As of December 2018, additions to the November 2019 wait list are still being accepted. Traditional Case-based Clinical Exams will be offered in February 2019 and June 2019, with both sessions full. This will mark the final time this exam type will be offered. Scenario-based Oral Clinical Examinations for 2020 will occur in February, July and November with specific details announced in May 2019. Certification Renewal requirements have not changed.
- To assist in preparing for the Scenario-based Clinical Examination, a <u>Study Guide</u>, including sample cases, is available on the ABO website. Orthodontic programs interested in hosting case-based mock board exams are welcome to contact <u>ABO examiners</u> listed on the website for school visits. <u>ABO advocates</u> continue to be available to visit orthodontic programs to provide education on board certification requirements and the Scenario-based Clinical Examination. A workshop for educators/advocates will occur at the 2019 AAO Annual Session. An Open House/Info Session for anyone interested in learning more about the examination will be offered and will include interactive stations manned by ABO directors allowing for additional opportunities for information and questions on the examination.
- New software functionality has been implemented on the <u>ABO website</u>. The new software allows for an enhanced orthodontist locator, ability to add a professional head-shot to profile, ability to edit/add personal and practice information with unlimited offices, increased security, user specific dashboard notifications, payment history, upload/track CE credits and print complimentary verification letter.
- The ABO recently completed a renovation of the Exam Center, increasing the total testing rooms to 12, allowing additional accommodations for examinees to participate in the board certification exams.
- The AAO Board endorsed the ABO's shift to a Scenario-based Examination system.

- An <u>AAO ABO podcast</u> with Drs. **Myron Guymon** and **Larry Tadlock** was released in March 2018, discussing the Scenario-based Oral Clinical Examination. A follow-up podcast on the status of the new examination is scheduled to be released soon.
- ABO educational materials available to board certified orthodontists have been updated to include the new examination information.
- The ABO distributed complimentary ABO measuring gauges to first-year residents along with pyramid posters for the school at requesting CODA-accredited orthodontic programs.
- Educators Symposium: The ABO will offer an Educator/Advocate Workshop during the 2019 AAO Annual Session in Los Angeles, Calif.
- The College: The ABO and the College (CDABO) continue to work together to support orthodontic programs in their preparation for the ABO Clinical Examination thru the advocacy program. To date, all 73 orthodontic programs have at least one advocate assigned to their school. In addition, the College offers courses for examinees to prepare for the clinical exam during Annual Session. The 2019 ABO award recipients will be recognized during the 2019 College of Diplomates Luncheon held during Annual Session.





COUNCIL ON COMMUNICATIONS (COC)

The Consumer Awareness Program (CAP) is now in its 13th year. Its purpose is to raise awareness among consumers about the benefits of orthodontic treatment provided by AAO orthodontists.

CAP outreach includes paid messaging (advertising) and public relations (stories in the news media). Paid messages are delivered digitally using search engines (Google, Yahoo!, Bing), websites and social media ads. We also work with other online avenues to distribute more modern content. The advantages of digital marketing are many. Vast amounts of data about consumers enable us to tailor and deliver messages to a variety of audience segments, based on gender, age, household income, whether there are children in the household, and an array of other factors.

Whether paid or unpaid, all messages drive consumers to <u>aaoinfo.org</u> where they can learn more about orthodontic treatment provided by AAO members, and then locate nearby AAO members through the "Find an Orthodontist" search.

Messaging is doing a phenomenal job of driving record numbers of traffic to the website. Here is a recap of FY 2018 results:

- AAO launched an online <u>Parents Guide to Orthodontics</u>. With nearly 500,000 visitors to the guide, readers spent an average of 14 minutes on the page. An <u>Adults' Guide to Orthodontics</u> was also recently announced.
- The AAO's Council on Communications partnered with Buzzfeed to produce this video, encouraging consumers to see a real orthodontist.
- A video ad from the AAO's new "That Feeling When..." social media campaign went viral. The ten-second <u>video</u> was seen over 2.6 million times, generating over 660,000 engagements and driving over 400,000 visitors to the AAO consumer website.
- Enhanced websites for <u>AAO members</u> and <u>consumers</u> were launched, featuring a new look and improved functionality.
- The AAO launched a <u>Questions to Consider When Researching Direct-to-Consumer Orthodontic Companies</u> web page on the consumer site, as well as a flier to download.
- There were 5.6 million visitors to the AAO consumer website
- More than 64,000 uses of the Find an Orthodontist locator occurred in 2018.

COUNCIL ON ORTHODONTIC EDUCATION (COE)

The Orthodontic Advanced Education Program Chairs and Program directors gathered at the MSO Educator's Meeting held in conjunction with the MSO Annual Session at the Radisson Blu Mall of America. In addition to the majority of MSO university chairs and program directors, the current president of the AAO, Dr. **Brent Larson** attended.

Discussion items included a change in the deadline for PARC grant submissions from December 15 to November 16. The AAO's advocacy program was reviewed for the educators. The ABO scenario based oral examinations were also a topic of discussion. Our ABO director, Dr. **Pat Foley**, has been very helpful in his communication to the educators. It was noted that the AAO 2018 House of Delegates has approved reinstatement of faculty fellowships for 2019-2021. Newly proposed CODA recommendations establishing FTE faculty minimums and training requirements for new technology and curriculum were also discussed. Several guests also made presentations to the group. Dr. **Deb Lien**, updated the educators on status of student loan legislative progress and other governmental issues. Dr. **Nellie Kim-Weroha** introduced **Lynne Thomas Gordon**, AAO Executive Director, to the group and provided perspective of women's issues. Dr. Kim-Weroha also requested recommendations of women speakers and emerging leaders.

All of AAO COE members met October 29 at headquarters for our annual face-to-face meeting. Dr. **Norman J. Nagel**, Board Liaison for 2018, reported that the BOT approved the CODA Review Committee's edited report to move forward to CODA. He also noted that the BOT has requested the Council on Orthodontic Practice (COOP) to develop an educational program that consists of videos, webinars, podcasts and other appropriate means to help members be proficient in aligner treatment. He emphasized the need for all Councils to use the <u>AAO strategic Plan map</u> as a compass for decision making today and going forward. He announced that GORP will be held in St. Louis on July 25-28, 2019.

Agenda items included election of a new chair which has not yet been announced. The process of Partners in Research (PIR) was reviewed by Drs. **Kelton Stewart** and **Anil Ardeshna**. Both are members of COE. PIR is a frequently used survey tool using AAO databases. However, there is the potential to over survey the membership. The number of yearly surveys and academic merit are issues for PIR. Both felt the program was worthwhile to keep but additional guidelines should be developed. CODA site visitor training was discussed. The Council felt that it would be advantageous for new consultants to participate as an observer prior to their first accreditation assignment. This will be reviewed with the commission.

The 2019 Jeryl D. English Educational Leadership Conference will be held Friday, May 3 at the JW Marriot, Los Angeles. Dr. **Stewart Kelton**, president of the Society of Orthodontic Educators (SOE) has developed an excellent program. Highlights include presentations from leaders in American and Canadian orthodontic education, CODA updates, recognition of new faculty and faculty advancement. I look forward to seeing everyone.

COUNCIL ON MEMBERSHIP, ETHICS AND JUDICIAL CONCERNS (COMEJC)

- Continues to monitor membership trends, including quarterly recruitment/retention
 - AAO's 2018-19 membership renewal cycle concluded on January 4, 2019 when members were dropped for non-payment of dues.
 - o 476 Active and Life Active members were dropped on January 4th.
 - o Through January 31st, 139 of those members (29.2%) rejoined.
 - AAO's 2018 year-end U.S. market share was 86.6%, down from 87.5% in 2017.
 - AAO has improved its success with reinstating former members in 2017-18 and 2018-19, including 134 reinstated Active and Life Active members during those years (compared to 94 the previous two years).
- Assisted with AAO's membership renewal processes in fall 2018 by conducting personalized outreach to non-renewed members within their constituents. 57.7% of targeted members renewed between November 2nd and January 4th.
- Continues to emphasize the importance of ethics within the orthodontic specialty, including promoting the AAO's Principles of Ethics to members. Council is contributing a blog article on the topic via the AAO consumer website (aaoinfo.org).
- As assigned by the BOT, Council is studying:
 - o Possible changes to the definition of AAO Life Active membership.
 - Accommodations for members who need flexibility in maintaining membership to help balance the demands of practicing and raising children.
 - Possible changes to the AAO membership model (e.g., membership tiers and bundling) to address the evolving needs and demographics of AAO members.
- Council's next face-to-face meeting will be Friday, January 10, 2020 at AAO headquarters.

COSA reviewed 24 applications for the Hellman, Sicher and Graber Awards. The winners will present their lectures during Annual Session.
