## MSO's Graber, Bishara, Miller and Whipps Honored in Hawaii

Several members of the Midwestern Society of Orthodontists were nationally recognized at the 112th Annual Session of the American Association of Orthodontists in Honolulu, Hawaii. Dr. **Samir Bishara** (posthumously) from Iowa, Dr. **Lee Graber** from Illinois, Dr. **Francis Miller** (posthumously) from Missouri and Dr. **J. Franklin Whipps** from Illinois were acknowledged for their various contributions to orthodontics and humanity.




Dr. Bishara from Iowa City received the Louise Ada Jarabak Memorial International Teachers and Research Award from the American Association of Orthodontists Foundation. His daughter accepted the award on his behalf. In his 40 years at the University of Iowa, Samir distinguished himself as a respected author, researcher and educator for decades of orthodontic residents. He also served on

the review boards for several orthodontic journals.

In addition, Samir received many honors, including a Guggenheim Fellowship, and was an honorary member of many international organizations. He was a past-president of the College of Diplomates of the American Board of Orthodontics and spent many years involved with that organization.

Dr. Graber from Vernon Hills, Illinois, received the Albert H. Ketcham Memorial Award from the American

Board of Orthodontics. Lee has been involved in almost every aspect of orthodontics from the Illinois Society of Orthodontists to the World Federation of Orthodontists. Serving as president of those two organizations as well as the Midwestern Society of Orthodontists and the American Association of Orthodontists, Lee's impact not only on these organizations but on all aspects of dentistry can be felt by all of us. Lee's vocation and avocation are one-and-the-same – orthodontics. In addition to all of his involvement in organized orthodontics, he also is a respected educator, author, speaker and practitioner.

Once again this year, the MSO had several recipients of the most prestigious awards given out in Hawaii. Dr. **Lee Graber** received the ABO Ketcham Award and, as always, was most gracious in his words of acceptance making all of us in attendance feel like we got the award with him. Dr. **Samir Bishara** received the AAOF Jarabak Award and his award was accepted by his daughter who shared some personal anecdotes about growing up in that orthodontic family. - Asked the AAO Board of Trustees to examine the costs and availability of consultants with association management expertise who may be able to help the AAO determine whether a change in our governance model would help us to stay relevant and effective in the future.
- Approved updated definitions of comprehensive orthodontics, interceptive orthodontics, limited treatment

and preventive orthodontic treatment (*see page 9*).

- Added some recommendations regarding patient transfer to the AAO Clinical Practice Guidelines.

- Approved investigating whether the AAO should be part of the *Image Gently* campaign coordinated by the American College of Radiologists. *Image Gently* includes online teaching materials and checklists to help providers use the lowest radiation dose to obtain the necessary information when performing imaging studies on children.

- Recognized outgoing AAO Council members for their service including MSO member Dr. **Mark Dake** for his eight years of service on the Council on Government Affairs.

- Elected new AAO Council members including MSO representative Dr. **Deb Lien** to the Council on Government Affairs.

In this election year, it is particularly important that our AAO Political Action Committee has the dollars available to gain access to influential members of Congress. co-recipient of the Humanitarian Award from the American




Association of Orthodontists. His daughter, Dr. **Jackie Miller**, accepted the award on his behalf. Although Frank practiced in Washington, his compassion extended around the world. He was a founding member of the Washington Overseas Mission, which provided dental and medical services to Central America as well as to Africa, Kosovo,

Cambodia and Haiti. The organization inspired by his passion continues to this day to provide care in Honduras. Frank earned a medical degree in 2002 so he could do even more.

Frank taught orthodontics at Washington Univer-

sity, was on the board of East Central College in Union, Missouri, was a co-founder of the Four Rivers Vocational School and the St. Francis Borgia Regional High School Academic Association.

Dr. Whipps from Centralia, Illinois, was a co-recipient of the Humanitarian Award from the American Association of Orthodontists. Frank began traveling on mission trips with the Christian Medical and Dental Society in the 1980s, providing needed services in the Caribbean, Central America and South America. In 1993, he established the Belize Mission Project to provide

# AAO Council and Affiliate Group Reports

## Council on Communications

The AAO Council on Communications (COC) next meeting is scheduled for June 8-9, 2012 in St. Louis.

The main COC project has been the launch of the *My Life. My Smile. My Orthodontist.*<sup>sm</sup> campaign, which reaches out to potential adult patients as well as to parents of children and teens. The campaign's target is women ages 25 to 49. The main message is:

*Whether you're considering clear aligners, retainers or today's braces, an orthodontist is the smart choice. Orthodontists are specialists in straightening teeth and aligning your bite. They have two to three years of education beyond dental school. So they're experts at helping you get a great smile – that feels great, too.*

New advertising and public relations firms were hired to develop the campaign, including a new consumer-facing website with a new URL: [MyLifeMySmile.org](http://MyLifeMySmile.org). All messaging drives consumers to the website where they can learn more about orthodontic care and orthodontists. Consumers can use the updated "Find an Orthodontist" service to locate AAO members near them.

The tagline text *My Life. My Smile. My Orthodontist.*<sup>sm</sup> is being phased in so that it appears under the AAO's logo. New TV commercials, print ads and Web banner ads were developed with the tagline. They were deployed with the mid-January 2012 launch.

The effectiveness of the campaign is being tracked through web analytics tools and through a tracking study conducted for the AAO by Millward Brown, a global leader in the field of advertising tracking.

AAO members can use the materials created for the Consumer Awareness Program (CAP) to promote their own practices. View the materials in the Practice Marketing Solutions section of [AAOmembers.org](http://AAOmembers.org) (look for the link on the home page). Materials can be used as-is or customized. Members who wish to customize materials can call the AAO, which has arranged for vendors who can assist with customization, at the member's expense.

A popular new feature on the consumer's site is "Ask an Orthodontist." Consumers may submit a question to be answered by an actual orthodontist. Since many of the same questions are asked repeatedly, as a consumer types in the question, responses from the knowledge base will appear when select keywords are entered. In most cases, the consumer's question is answered on the spot. If the consumer wishes to pursue submitting a question, he or she can

continue. Most questions have to do with the cost of care or where to find free care.

The "Find an Orthodontist" service was upgraded. When a consumer enters search parameters, a grid of results is returned. The grid displays members' names, addresses, telephone numbers, the dental and orthodontic schools attended, and the distance from the geographic center of the search results. If members have given the AAO their practice website addresses, the URL will display in the grid.

A study of general and pediatric dentists is in progress. The COC conducted studies of general dentists in 1996-97 and 2006. This is the first time the study was extended to include pediatric dentists. The qualitative and quantitative studies are intended to determine participants' opinions, needs, interests and concerns relative to orthodontists they have worked with and how relationships may have evolved over the past few years. It will help the AAO understand and quantify what drives or inhibits referrals to orthodontists. After the results are analyzed, recommendations will be made to help enhance relationships with general and pediatric dentists.

Two PowerPoint presentations are in development. Once completed, they will be posted for free download. One presentation will be suitable for use at a career-day presentation. The other presentation will be for use with school nurses, either in a one-on-one setting or to use at local or regional conventions. When complete, announcements will be made about the availability of the presentations.

## Council on Governmental Affairs

COGA and AAOPAC will convene in late June in Washington, D.C. to examine the remainder of the legislative session for opportunities to advance the AAO's agenda. Topping the agenda at this point are the expansion of limits on flexible spending accounts (FSAs), currently set at \$2,500, effective January 1, 2013. The AAO knows from surveys that over 60% of patients pay for orthodontic treatment with FSAs, and many have responded that the new limits will severely impact patients' ability to pay for orthodontic treatment.

The AAO also is actively lobbying to specifically exclude orthodontic appliances from the medical device tax. Currently, the tax does not apply to orthodontic devices, but a regulatory ruling easily could change that.

The Council also will be monitoring tax reform, as significant changes are being considered to the tax code. Small business tax reform likely will be an item on Congress' agenda next year. The AAO is actively working to build relationships with key lawmakers in an effort to ensure that small business health providers will be treated fairly and that the tax code will encourage economic growth and job creation so that high quality care can continue to be offered at affordable prices.

## Council on Orthodontic Health Care

COHC met via videoconference on January 21. COHC continues to focus on access to orthodontic health care, insurance coding and third-party payer issues.

The AAO Donated Orthodontic Services program is going strong in the five pilot states, Illinois, Indiana, Kansas, New Jersey and Rhode Island. The program is administered by Dental Lifeline Network, which was formerly known as the National Foundation of Dentistry for the Handicapped, which also administers the DDS program. Dr. **Steve Robirds** and I have participated in several conference calls related to establishment of a business plan for DOS that would allow expansion of the program into other states. A nominal \$200 fee is now being charged to help defray the administrative costs associated with the program. Dr. **Ara Goshgarian** was featured in a WGN-TV segment highlighting the DOS program in Illinois. The demand for services has been greater than expected, so if asked, please volunteer to participate in this program to further enhance access to orthodontic treatment for the underserved.

The Council was charged by the AAO House of Delegates to examine the current orthodontic definitions listed in the *AAO Policy Manual*. Based on this study, the COHC, along with input from the Council on Orthodontic Practice, forwarded a resolution to the House of Delegates for its consideration. It recommended removal of all references to specific adjunctive procedures from the orthodontic definitions. The goal of this resolution was to prevent expansion of the practice of insurance payers

“bundling” of procedures under orthodontic codes. The resolution passed and changes will be made to the *Policy Manual* reflecting the approval of the resolution. The COHC will continue to monitor this issue in the future.

The Council is working on a draft plan to ensure that the AAO is properly represented at the many coding and dental benefits conferences that take place throughout the year. We are fortunate to have Dr. **Norm Nagel** representing us at the newly established ADA Code Advisory Committee (CAC) and American Association of Dental Consultants meetings. Other meetings that are attended by COHC representatives or staff include the National Association of Dental Plans meeting and the National Dental Benefits Conference. The purpose of attendance at these meetings is to solidify relationships with third-party payers and ADA personnel associated with the CAC as well as other dental industry leaders. This will help highlight the importance of including orthodontic benefits in packages that are offered to employees. It also will be beneficial in making sure the interests of orthodontists are represented whenever coding issues arise at the CAC.

The Council also is exploring the use of medical codes for some orthodontic procedures, especially in surgical and cleft palate cases. It is hoped that some consensus can be arrived at in how to properly code procedures that are not adequately described in the dental codes. The AAO Dental Benefits Advisory Service is an excellent resource for all coding and insurance issues and is directed by AAO staff member **Ann Sebaugh**, who is excellent at getting even the most complex coding issues resolved. ## Council on Membership, Ethics and Judicial Concerns

When was the last time you were lost? Recently, my wife and I took a drive to a part of town we had not seen in a few years, which has undergone considerable growth. With a cloud-covered sky and winding streets, it wasn't long before we had no sense of direction or the way to navigate ourselves back to familiar territory. It struck me how seldom the "lost feeling" surfaces in us these days. With dash-mounted devices and smart phone applications, most folks now seldom suffer those anxious feelings associated with losing one's way. However, when it comes to ethics in orthodontic practice, do we have the same secure feelings that keep us from becoming lost?

Dr. **Peter Greco** has been providing insightful navigation systems of his own helping orthodontists become more familiar with the ethical landscape of orthodontic practice while also offering road maps to help us avoid that "lost feeling." Ethical pitfalls often can be avoided with the review of the AAO's *Principals of Ethics and Code of Professional Conduct* (found on the members' website) and the use of common sense rather than emotion. Dr. Greco's brief ethical scenarios help us become more familiar with the ethical neighborhood in which we work daily. COMEJC encourages all members to take advantage of the Ethics in Orthodontics articles found in the *AJO-DO*.

The 2012 House of Delegates amended the AAO's Position Statement on *Overlap of Treatment Between Specialties, and Ethical Practices of Specialists* by striking the last sentence of the first paragraph of the statement. The first paragraph now reads as follows:

### **Ethical Practices of Specialists**

In order for a dentist to ethically announce as a "specialist," the dentist must have successfully completed an advanced educational program in that specialty accredited by the Commission on Dental Accreditation. The scope of an individual specialist's practice shall be governed by the educational standards for the specialty in which the specialist is announcing.

The 2012 AAO House of Delegates also adopted amendments to *AAO Policy Manual* definitions for comprehensive orthodontics, interceptive orthodontics, limited treatment and preventive orthodontic treatment as recommended to the AAO Trustees by a COMEJC/COOP subcommittee. Amended definitions now read as follows:

### **Comprehensive Orthodontics**

Comprehensive orthodontic care includes a coordinated diagnosis and treatment leading to the improvement

of a patient's craniofacial dysfunction and/or dentofacial deformity which may include anatomical, functional and/or esthetic relationships. Treatment may utilize fixed and/or removable orthodontic appliances and may also include functional and/or orthopedic appliances in growing and non-growing patients. Adjunctive procedures to facilitate care may be required. Comprehensive orthodontics may incorporate treatment phases focusing on specific objectives at various stages of dentofacial development.

### **Interceptive Orthodontics**

Interceptive orthodontics is an extension of preventive orthodontics that may include localized tooth movement. Such treatment may occur in the primary or transitional dentition and may include such procedures as required for the redirection of ectopically erupting teeth, correction of dental crossbites or recovery of space loss where overall space is inadequate. When initiated during the incipient stages of a developing problem, interceptive orthodontics may reduce the severity of the malformation and mitigate its cause. Complicating factors such as skeletal disharmonies, overall space deficiency, or other conditions may require subsequent comprehensive therapy.

### **Limited Treatment**

Limited orthodontic treatment typically focuses on limited objectives, not necessarily involving the entire dentition. It may be directed at the only existing problem, or at only one aspect of a larger problem in which a decision is made to defer or forego a more comprehensive plan of therapy.

### **Preventive Orthodontic Treatment**

Preventive orthodontic treatment is intended to mitigate the development of a malocclusion. Typical services may include dental restorations, temporary prostheses space maintainers, replacement of prematurely lost deciduous teeth and removal of deciduous teeth that fail to shed normally when this might allow their permanent successors to erupt more favorably.

serve and would hope that you would not hesitate to contact me with regard to any association concerns or if you are interested in possibly serving on COOP.

At this past AAO Annual Session, our Council again hosted our Annual Practice Transition Conference as a stand-alone meeting on Friday. We had 101 attendees and this year's seminar was entitled *Practice Alohas: The How's, Why's and When's to Say Either Hello or Good-bye to a Practice*. The presenters were **Curt Nurenberg**, Drs. **Roger Levin** and **Tom Ziegler**. They shared their strategies and long-term perspectives on options to gradually and more lucratively transition a practice. The AAO's Practice Opportunities Program reported as of April 1 that we have 484 seekers and 152 opportunities available. In the first three months of 2012, we had 27 self-reported matches.

The Board of Trustees approved COOP to host a New and Younger Member (including orthodontic residents) contest in a video format to be delivered at the Annual Session in 2013. COOP will host this new competition in addition to continuing to host the Orthodontic Staff PowerPoint Presentation. In Hawaii, we did not have a sufficient number of submissions to meet the minimum policy requirements to hold the Staff Competition but are planning to do it in Philadelphia in 2013. COOP, during 2011 and 2012, hosted a series of 16 webinars for doctors, residents and/or staff on clinical and practice management topics. Committee presented an update on the AAO Foundation Craniofacial Growth Legacy Collections Project ([www.aaoflegacycollection.org](http://www.aaoflegacycollection.org)). The effort to fund this unprecedented undertaking, Legacy 300 Campaign, was completed ahead of schedule late last year, and MSO members played an important role in seeing this to fruition.

In addition to continued support for the Collections Project, the Directors approved a total of eight Biomedical Research Awards, 16 Orthodontic Faculty Development Fellowship Awards and two Education Innovation Award Planning Grants for a total of \$540,000 for 2012 Awards. Of those 26 funded proposals, five were from the MSO including Dr. **Phimon Atsawasuwana**, University of Illinois at Chicago and designated the *T.M. Graber Teaching Fellowship Award*; Dr. **Jose Bosio**, Marquette University; Dr. **Thyagaseely (Sheela) Premaraj**, University of Nebraska Medical Center; Dr. **Sundaralingam Premaraj**, University of Nebraska Medical Center; and Dr. **Lina Moreno Uribe**, University of Iowa.

For the next funding round, the Board budgeted support for the Collections Project and an additional \$600,000 for other awards. Award information for 2013 is expected to be on the Foundation website by the beginning of July and the deadline for proposals is December 14.

The Missouri Society of Orthodontists held its business meeting February 4, 2011 in Kansas City. The Missouri bylaws need to be reviewed and updated to coordinate with MSO and AAO bylaws. The bylaws will be voted on and approved by Missouri members at the next business meeting which will be January 18, 2013 in Kansas City at the joint Kansas/Missouri Orthodontists meeting.

Legislative Day on February 22 was one of the largest turnouts in years. Members of the Missouri Dental Association (MDA) began sending postcards last fall to the governor, representatives and senators and other representative leaders to share their thoughts on dental therapist and mid-level providers. The purpose of these cards was to discourage anyone from filing workforce legislation similar to the proposal advanced by the Missouri Dental Board.

Bills of interest in the House include:

- HB 1050 – Prohibits insurance companies from including capped fee clauses within their provider contracts for dentists and optometrists.
- HB 1078 – Would authorize the Department of Social Services to establish a “Dental Carve Out” within the State’s Medicaid program.
- HB 1890 – Includes language to prohibit insurance companies from capping fees on non-covered services.

Bills of interest in the Senate include:

- SB 899 – Requires a one-time transfer of certain fund balances, including the Dental Board fund, to the state general fund.
- SB 620 – Can be amended to include MDA’s capped fees legislation. Go to [www.modental.org](http://www.modental.org) for further information.

This is a good time to review your continuing education (CE) credits. This fall dental licenses will be required to be renewed. The Dental Board will be conducting another CE audit to check for compliance with its continuing education requirements. A reminder – the licensee must have accumulated 50 hours of CE between

CDABO case displays were presented by third-year residents Drs. Sawan, Cheba and **Andrew Bernas** in Hawaii, each presenting a case that they started and completed themselves.

We welcome Dr. **Osmar Baretto** who joined the department in January as a full-time term position orthodontist. Department of our provincial government, needy children who would benefit from orthodontic treatment are identified and treated by our residents in the program. Over the past decade we have provided over half-a-million dollars of “free” orthodontic care for these children. We are presently looking at expanding this program to an on-site outreach clinic where we will offer screening and interceptive orthodontic services at the facility to children in need who otherwise would not be able to access even basic interceptive orthodontic care.

Dr. **Gary Levine** has taken over as course coordinator of Biomechanics and is also the Principal Orthodontist in our TAD clinic. Dr. **Susan Tsang** currently assists Dr. Baretto in the Craniofacial Difference/Cleft Palate Clinic. Osmar took over as the Principal Orthodontist in this clinic in January 2012. Dr. **Luis Piedade** from Toronto is the Principal Orthodontist in our Clear Aligner Clinic and flies in every six weeks at his own expense. Dr. **Jeff Bales** is the Principal Orthodontist in our Self-ligating Clinic and he will be assisted by Drs. **Warren Cohen** and **Ron Wolk**, both from Calgary. We bid a hearty welcome to Ron as we say thank you and farewell to Dr. **Chung Yue**, also from Calgary, who has been teaching in Jeff’s clinic for a number of years.

We remain indebted to all our part-time orthodontists who teach in our orthodontic clinics: Drs. **Frank Hechter, Gerry Solomon, Jeff Bales, Tim Dumore, Hermann Lee, Gary Levine, Susan Tsang, Milos Lekic, Christie Laberge, Luis Piedade** as well as Oral Surgeon Dr. **Lee McFadden** and Periodontist Dr. **Anastasia Kelekis-Cholakis**.
