The 2011 AAO Annual Session in Chicago was a resounding success by any measurement you wish to use. One very obvious measurement was the number of MSO members who were nationally recognized for their commitment to the specialty of orthodontics. Dr. **Rolf “Buzz” Behrents** received the Louise Ada Jarabak Memorial International Teachers and Research Award; Dr. **James Gjerset** received the Eugene and Pauline Blair American Association of Orthodontists Foundation Distinguished Service Award; and Dr. **Russ Kittleston** received the Earl E. and Wilma S. Shepard Distinguished Service Award. In addition, Dr. **Frank Green** was honored with MSO’s 2011 Earl E. Shepard Distinguished Service Award, and numerous MSO members were recognized for their service on various national councils and committees.

Dr. Behrents (Missouri) received the Jarabak Award from the American Association of Orthodontists

Foundation at the Excellence Luncheon. Buzz received his B.A. from St. Olaf College, his dental training at Meharry Medical College, his orthodontic training at Case Western Reserve and a Ph.D. from the University of Michigan. He also has received an honorary doctorate from the University of Athens in Greece and various awards for

his research, has authored and co-authored numerous articles on orthodontics and facial growth and has lectured extensively throughout the U.S. and abroad.

Buzz currently is the executive director of the Center for Advanced Dental Education at Saint Louis University where he also serves as professor and director of orthodontics. He continues to serve as a research associate at the Bolton-Brush Growth Study Center at Case Western.

An avid supporter of the Foundation, Buzz was an early recipient of the Eugene and Pauline Blair American Association of Orthodontists Foundation Distinguished Service Award, as he is considered the “founding father” of the AAOF awards program, having first met with the Foundation Board of Directors in this regard in 1991.

Dr. Gjerset (formerly of North Dakota) received the Eugene and Pauline Blair Award from the Foundation at its annual breakfast meeting in Chicago. This award is given from time-to-time by the Foundation’s Board of Directors to

Although the current officers will stay onboard until the conclusion of the fall board conference call, the following officers were elected and installed: Drs. **Babette Cohen** (Manitoba) – President; **Ross Crist** (South Dakota) – President-elect; **John Crawford** (Wisconsin) – Vice President; and **Deb Lien** (Minnesota) – Secretary/Treasurer.

What a great AAO Annual Session we all had in Chicago as MSO's Dr. **Lee Graber** concluded his year as AAO President! The meeting was hugely successful due to the hard work and commitment of the planning committee which included many MSO members: Drs. **Steve Litton**, **Buzz Behrents**, **Jim McNamara**, **Katie Graber**, **Steve Marshall** and **Jackie Miller**, and Ms. **Rosemary Bray**, **Bonnie Litton**, and **Charlene McNamara**. The result was a record number of orthodontists, nearly 7,000, attending an AAO meeting!

The AAO Annual Session also is a time when many individual awards are given, and the MSO had many deserving individuals receive some of the most prestigious national awards. Dr. **Jim Gjerset** received the Eugene and Pauline Blair American Association of Orthodontists Foundation Distinguished Service Award; Dr. **Buzz Behrents** was honored with the AAO's 2011 Louise Ada Jarabak Memorial International Teachers and Research Award; Dr. **Russ Kittleson** was presented with the ABO's Earl E. and Wilma S. Shepard Distinguished Service Award, and Dr. **Lee Graber** was surprised with the announcement that he will be honored with the ABO's 2012 Albert H. Ketcham Memorial Award next year in Hawaii. Congratulations to all these deserving members!

In Chicago, the House of Delegates was finished with its business in record time under the leadership of AAO Speaker **Keith Levin**. Here are some of the notable outcomes of this House meeting:

- Approved a dues increase of \$43 per member.

This is the first dues increase in ten years and will help keep the AAO in strong financial shape.

- Approved a continuation of the Consumer Awareness Program (CAP) for two more years to be funded by a member assessment of \$650 per year. This program will be directed by a new ad agency partner in the coming years which will bring some fresh ideas and new energy to our continuing message.

- Recognized outgoing AAO Council members for their service including MSO members Drs. **Alison Fallgatter** – Council on New and Younger Members; **Greg Hoeltzel** – Council on Orthodontic Health Care; **Steve Litton** – Council on Membership, Ethics and Judicial Concerns; **Leo Sinna** – Council on Insurance; and **Tom Southard** – Council on Scientific Affairs.

- Elected new AAO Council members including MSO representatives Drs. **Rick Fuchs** – Council on New and Younger Members; **Mike Durbin** – Council on Orthodontic Health Care; **Dennis Sommers** – Council on Membership, Ethics and Judicial Concerns; **Steve Henseler** – Council on Insurance; and **Jeffrey Nickel** – Council on Scientific Affairs.

- Approved a new AAO logo (see the front cover) to help brand our organization. This logo is designed to resonate with the public and is the result of more than two years of effort. You are encouraged to begin to use the new logo immediately but are able to use the existing logo as needed until May 2013 in order to use your existing stock of office materials. Find more information about the logo at aaoinfo.org.

- Appointed a Governance Restructure Study Committee to report back to the 2012 House on the structure and governance of the AAO.

- Approved the recommendations of the Governing Documents Committee to streamline the AAO's governing documents.

The MSO will need new representatives for the Council on Governmental Affairs starting May 2012 and for the AAO PAC beginning January 2012. If you have interest in either of these positions, please contact me as soon as possible.

I am a member of the planning committee for the joint mid-winter meeting with the American Association of Pediatric Dentistry that will take place January 27-29, 2012. The topic will be *Age-Appropriate Treatment of the Developing Occlusion: Common Problems – Consensus Solutions*. The location is beautiful Marco Island, Florida, and I can assure you that the program will be worthwhile. I encourage you to consider inviting a pediatric dental colleague to travel with you to the meeting as it will give you an opportunity to solidify your working relationship by learning together. Watch for program and registration information at aaoinfo.org.

AAO Council and Affiliate Group Reports

These reports are submitted by MSO's representative on each of these councils and affiliate organizations.

Council on Communications

The Council's summer meeting was held in St. Louis on July 22-23, and the winter meeting is scheduled for December 2-3, 2011.

The AAO produces and distributes public service announcements (PSAs) to TV stations in the U.S. and Canada and radio stations in the U.S. There were a significant number of airings for both the **Emmitt Smith** and **Jennie Garth** PSAs on radio and TV.

A continuous tracking study is being executed by Millward Brown, a global leader in the field of advertising tracking. Millward Brown utilizes a national network of survey participants who complete detailed surveys on advertising and communication for a wide range of products and services. For the AAO tracking program, Millward Brown utilizes panelists representing the Consumer Awareness Program's target audience – adults who have at least one member of their household aged 5-17 and who have household incomes of \$40,000 and up.

Questions in the survey are designed to gather data on members of the target demographic. Topics covered by survey questions include:

- Usage or planned usage of orthodontic treatment by all household members;
- The professionals providing or likely to provide treatment, if applicable;
- The method of treatment being used or likely to be used;
- Use of the Web, including braces.org, to gather information about orthodontic treatment;
- Awareness of the qualifications of orthodontists;
- Magazine readership;
- If someone in the household (adult or child) has slight or noticeable dental imperfections and the current status of plans to have orthodontic treatment (if applicable);
- Impact of current economic conditions on the choice not to pursue orthodontic treatment.

The AAO will use tracking data for long-term assessment of the effectiveness of the Consumer Awareness Program. Because continuous tracking generates data on a weekly basis and is reported quarterly, it provides the opportunity to make ongoing adjustments to the campaign's media plan and communication strategy. On a long-term basis, the data are expected to provide indicators of how to continuously improve this program.

The following are some First Quarter (January 18-March 28, 2010) and corresponding Fourth Quarter (Sep-

tember 27-December 12, 2010) results from the Market Share Tracking Study;

Percentage of Kids in Orthodontic Treatment

First Quarter: 23% of kids have orthodontic correction (braces or trays), with the majority made up of kids having braces vs. clear removable aligner trays

Fourth Quarter: 22% of kids have orthodontic correction (braces or trays), with the majority made up of kids having braces vs. clear removable aligner trays

Percentage of Adults in Orthodontic Treatment

First Quarter: 7% of adults have orthodontic correction in the form of braces or trays

Fourth Quarter: 8% of adults have orthodontic correction in the form of braces or trays

Orthodontic Patients Receiving Treatment by an Orthodontist

Council on Governmental Affairs

The Council has been working with the Board of Trustees, staff and legislative counsel in Washington to identify and prioritize issues for the foreseeable future. Currently, it has identified the following issues as its top two priorities:

- The elimination or increase of the cap on flexible spending accounts, currently set at \$2,500 beginning January 1, 2013. Since a large percentage of orthodontic patients pay for treatment with FSAs, the capped amount would amount to a significant increase in the cost for treatment. Several bills have been proposed, but none have gained a critical majority for passage.

- The elimination of the medical device tax, set to go into effect next year. While the tax, which was part of the Affordable Care Act (healthcare reform), currently does not apply to orthodontic appliances, it could in the future. The definition of the categories of devices subject to the tax are left to a regulatory determination as opposed to legislation.

The AAO is also the chair of the Organized Dentistry Coalition, a loose confederation of predominately business-oriented dental groups such as the ADA, AAOMS, AAPD and others. The Coalition has been active in several issues, including the support of bills which would repeal the FSA cap and the medical device tax as well as other general small-business related issues.

The Council next meets in September, at which time it will reassess the AAO's legislative agenda and begin to prepare for 2012. Additionally, it will begin to plan the 2012 Professional Advocacy Conference, set for January 23-25 in Washington, D.C. The Conference, as in past years, will be open to all interested AAO members. Our practice transition program was filled to capacity with 115 participants, including many students and new grads hoping to make a connection with the right "gray-haired" orthodontist who may be intending to transition out. The reviews have come in very positive and we will host this again in Hawaii.

The 2011 Staff Presentation Competition was held on Monday. Eight staff members were chosen out of 26 entries to compete. During the current fiscal year, the participation of AAO members in AAO endorsed programs that are under the AAOSI umbrella has held steady. Here is some information on those programs.

Transfirst Health Services: 175 members are enrolled, mainly in its credit card processing services. AAOSI staff have negotiated a reduction in processing fees as a result of our participation and longevity. Please consider using this service in your practice.

Medjet Assistance, LLC: 453 AAO members are now enrolled in this program which provides assurance of medical transportation while you travel in and out of the country.

Oakstone Publishing: The Oakstone Publishing Educational Program continues to remain steady – 1,048 members participated in this program as of December 31, 2010. The AAO is paid a 6.5% royalty from all paid subscriptions.

Springstone Financial Patient Financing: This service offers a third-party option for patient financing for orthodontics. Due to current economic conditions, Springstone has found it harder to find acceptable clients, but they continue to offer this program to our members/patients. For 2011 AAO will receive \$235,000 in royalties from Springstone.

Endorsed Insurance Programs: The insurance program continues to be successful. Medical, term life, disability, business overhead, professional liability, business office, employment practice liability, workers compensation and business umbrella insurances are all available to AAO members.

Voluntary Staff Certification: This program, started in response to member requests for help in retaining quality orthodontic staff, is in its infancy. As of June 2011, 115 staff have been certified as Specialized Orthodontic Assistants. This program will continue to be promoted by AAO.

Association Management Services: AAOSI staff successfully continue to provide management services to PCSO, NESO and the California Association of Orthodontists. This is a profitable venture for AAOSI and the contracts with these entities continue.

AAOF Contribution: The AAOSI Board of Directors contributed \$50,000 to the AAOF Legacy Collection Fund in the name of Dr. **James Gjerset** and all the other Eugene and Pauline Blair American Association of

Orthodontists Foundation Distinguished Service Award winners. This presentation took place at the AAOF breakfast business meeting during the recent AAO Annual Session in Chicago.

American Association of Orthodontists Political Action Committee

The Board of Directors met on January 24, 2011, at the Renaissance Mayflower Hotel in Washington, D.C. **Kevin O'Neill** from Patton Boggs, LLP, briefed the Board on the 2010 elections and discussed the various strategies the PAC may want to consider for the 2012 cycle.

John Hancock, fundraising consultant, led a discussion with the PAC Board. Topics covered were scheduled for monthly conference calls including state liaison list update, campaign themes for the 2012 election cycle and regional goals.

The PAC Board discussed the timing of contributions during an election year and how it relates to requests for funding from AAO members. It was determined that staff would develop a contribution form which would be placed on the AAOPAC's portion of the AAO website.

Contribution amounts for the last quarter of 2010 were substantially higher than the same period in previous years. This was attributed to efforts from the state liaisons as well as a good response for the *Program 50* campaign. *Program 50* is the late-cycle contribution campaign launched by AAOPAC in October 2010. The purpose of the campaign was to increase the number of late-election cycle contributions of \$50 or more with the goal of one out of four members contributing to AAOPAC. Currently, an average of 14% of AAO members contribute to the PAC on an annual basis with an average contribution being approximately \$250.

Starting in February, AAOPAC invited a constituent liaison group to join in on monthly conference calls. MSO state liaisons were the first group to participate. On the February 10 conference call, John Hancock led a discussion

The Missouri Society of Orthodontists held a business meeting Friday, February 4 in Kansas City. The Missouri bylaws need to be reviewed and updated to coordinate with MSO and AAO bylaws. The bylaws will be voted on and approved by Missouri members at the next business meeting. A \$5,000 donation to the AAOF Legacy collection was passed.

The 2011 legislative session ended on May 13. The legislation that authorized Missouri to develop a dental Medicaid carve-out passed. House Bill 827, which would have expanded the hygiene scope, was stopped from advancing. House Bill 669 would have prevented insurance companies from capping fees for dental services but did not pass. Discussions already have begun on how to get the bill passed next year.

In May the Missouri Dental Board held a meeting to hear comments concerning the development of a dental therapist program in Missouri. This was in response to a proposal in which a therapist would be able to provide some restorative and surgical dental services without a dentist present. The Dental Board voted to support a dental therapist category and asked the department to make its creation a legislative priority for next year. Some are concerned about the concept of dental therapists. For more information go to www.modental.org.

A.T. Still University announced they are starting a dental program at their Kirksville campus. The program plans to begin by fall of 2013, and to start with a class of 45 students. The program will partner with Community Health Centers around Missouri.

written and clinical. The Board has spent a lot of time structuring the Written Examination and deciding how to conduct the Clinical Examination.

The Clinical Examination in Dallas, Texas, February 16-23, utilized 43 examiners to examine 852 cases. The examination included Initial Certification, First Recertification and the traditional examination for orthodontists completing the Option I or Option II certification pathways. The ABO certified or recertified 141 of the 172 examinees which is almost an 82% success rate.

There was a marked increase in the June 2011 examination as compared to the November 2010 St. Louis Clinical Examination. There were 35 new Diplomates certified or recertified during the November Examination. The June examination graded 113 examinees with 85 completes which is a 75% rate of completion. The Initial Certification Examinees were 26.5% with a total of 30. Six

ICE and 16 Gateway examinees were from the Midwestern Society of Orthodontists. There were eight directors, seven past directors and seven previously trained examiners in attendance for the examination. Dr. **Steven Marshall** from the MSO was one of the trained examiners. The examinees are asked to critique the process when finished and a recurring comment is that too much time is spent on the two board cases the examinees are asked to diagnose and treatment plan. At this June's examination we decided to use only one board case to be able to spend more time with the examinees' six case reports. The examiners were very positive and felt the examination did flow more easily. The Board was very positive because we had four orthodontists register for the examination who did not accept the gateway offer, and there were three orthodontists who voluntarily recertified.

At the \$10,000 donation level, a unit can be dedicated. Firstly, the growing fund to support a second teaching position was to be officially titled the Dr. Don Thompson Endowed Professorship. Dr. **Don Thompson**'s teaching in the postgraduate orthodontic program began in 1965, with variations in time commitment over the years. The second was the official assignment of space in the School of Dentistry to the Dr. George Muehlebach Seminar Room. Dr. **George Muehlebach** was a part-time clinical instructor in the Orthodontic Department from September 1980 until his untimely death in 2005.

We were very fortunate to have **Glenn Sameshima**, DDS, PhD, give the 2011 Dan L. Blackwell Lecture. He is Chairman and Program Director of the Advanced Orthodontic Program at the University of Southern California School of Dentistry, Los Angeles. Dr. Sameshima's topic focused on issues such as evaluating outcomes to test claims of appliance efficiency and the controversies that plague orthodontists when reading the current literature concerning treatment outcomes.

Next year, the Dan L. Blackwell Lecture will be held on June 1, 2012, presented by Dr. **Sarandeep Huja**, Associate Professor and Graduate Program Director of the Division of Orthodontics at The Ohio State University College of Dentistry. His topic will be *Bone Remodeling in the Clinical Arena: From Diagnostics to Therapy*.

This year marks the 100th anniversary of orthodontic education in Kansas City. Thanks to the investigative work of Dr. Thompson, we have been able to establish the time-line of successive institutions that eventually resulted in our postgraduate program of today. The Kansas City

School of Orthodontia, organized by Dr. **Martin Dewey**, professor of Orthodontia, at the Kansas City Dental College, opened in 1911. In 1914, the name of the school was changed to the Dewey School of Orthodontia. He also had a private practice in Kansas City. In 1917, he moved his school to Chicago.

The International School of Orthodontia, which started in St. Louis in 1907, was brought to Kansas City by Dr. **William Brady**, Dean of the Western Dental College, and Dr. **Hugh Tanzey**. Dr. Brady sold his interest in the school to Drs. Tanzey, **R.J. Rinehart** and **George Hillias**. Beginning with the 1917 session, and continuing through 1930, the sessions were held in the Western Dental College and later in the Kansas City Western Dental College. Orthodontic education took a sabbatical in Kansas City from 1931 until 1946. In 1946 the Kansas City Western Dental College began its first dental specialty program, a 12-month course in orthodontics. Dr. **Leo Rogers** was a member of the first class. Dr. **Harold E. (Gene) Thompson** was a member of the second class and was a life-long friend and teacher in the department. Since the department's beginning in 1946, the school has undergone two name changes and moved to a new location in the Hospital Hill Medical Complex. Today, the Department of Orthodontics and Dentofacial Orthopedics and the Advanced Education Program in Orthodontics and Dentofacial Orthopedics are part of the University of Missouri Kansas City School of Dentistry and are positioned along with the support of a wonderful alumni association to meet the challenges of the 21st century.

It is with regret that we report to alumni that Dr. **Bob Craven** has retired from teaching at UMKC Orthodontics. Bob has dedicated himself to the Thursday morning postgraduate clinic for 12 years. Thanks, Dr. Craven, for giving your time and energy for all these years.
